

**INDEX OF WITHHELD ENRON-RELATED FOIA DOCUMENTS**  
**October 22, 2002**

The documents on this index may be responsive to one or more of the following requests made to the Federal Energy Regulatory Commission for Enron-related documents under the Freedom of Information Act (FOIA), 5 U.S.C. § 552: FY02-26 (Judicial Watch I), FY02-43 (Associated Press), FY02-61 (Los Angeles Times), FY02-64 (Judicial Watch II), FY02-65 (Wall Street Journal), FY02-74 (Bloomberg), FY02-84 (Washington Post), FY02-105 (San Diego Union Tribune) and FY02-107 (Betsy Miller).
